Fairview

History

The Fairview District was planned in 1965 when Council requested, by resolution of the Planning Board, that a study be undertaken of the North Cooksville Community. Prior to this, Cooksville's northerly boundary ended at the CPR tracks. During this era, Cooksville, which was centred around the intersection of Hurontario Street and Dundas Street, was considered "downtown Mississauga". The lands north of the CPR tracks extending north to Highway 403 were then planned entirely as future residential lands. This changed with the evolution of Mississauga's City Centre in the early 1970s which progressed with the construction of Square One Shopping

Centre and other commercial developments north of Burnhamthorpe Road.

The development of a new City Centre and the relocation of many "downtown" functions from Cooksville to City Centre necessitated the need to plan for several surrounding residential areas to serve the City Centre and Fairview was one of them along with Creditview, Hurontario, Rathwood and Mississauga Valleys. The Fairview District was planned in 1980 as part of the Dundas-Fairview Secondary Plan which included the Fairview Community and portions of the Cooksville neighbourhoods south of the CPR tracks. As the lands south of the CPR tracks were amalgamated into a

larger Cooksville District in the early 1990s, the remaining residential lands between Cooksville and City Centre became known as the Fairview District. The Fairview District has evolved as a transitional residential area between City Centre and Cooksville but does not characteristically form part of either community.

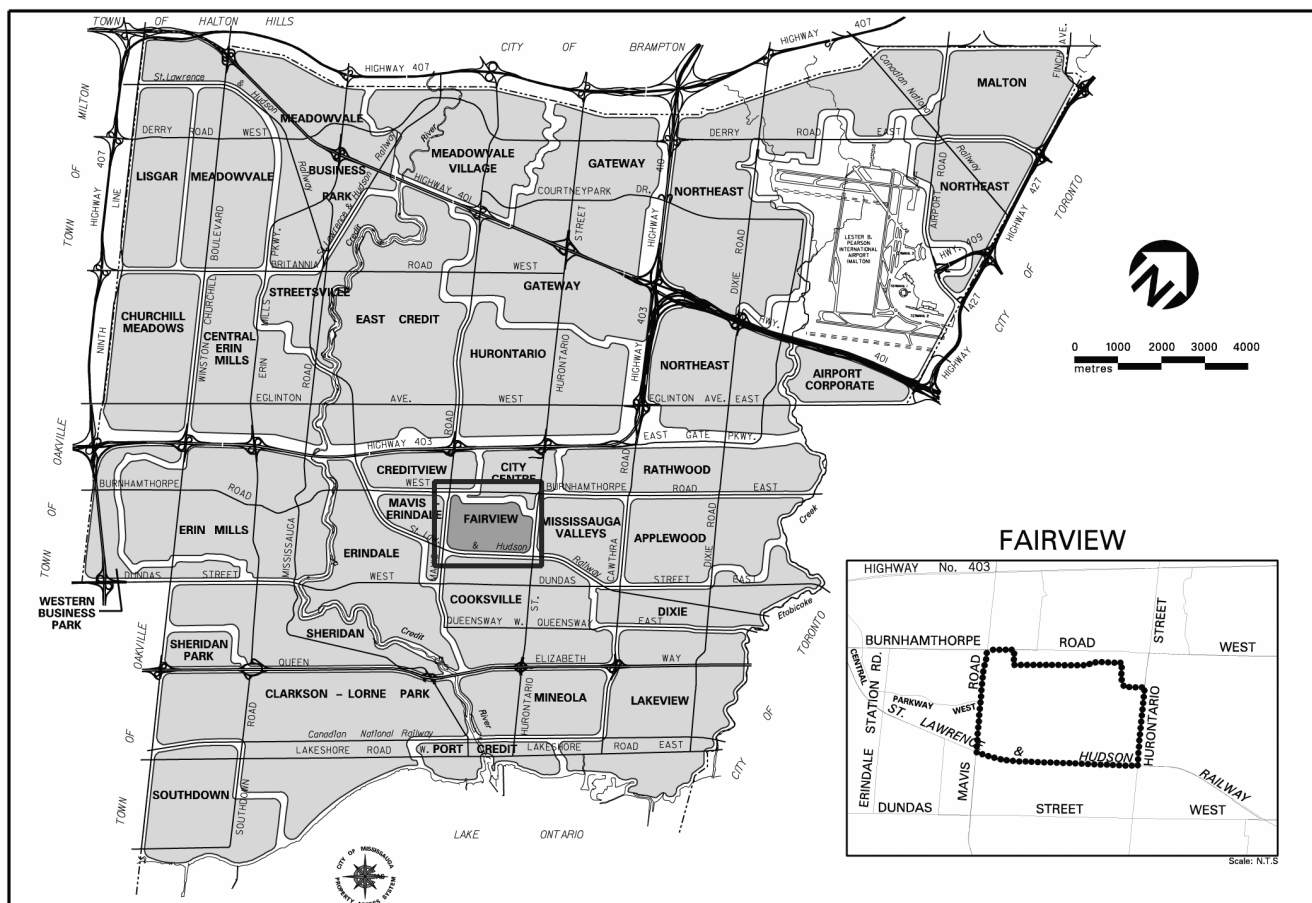


Figure 1 - Population Pyramid

(Total population 15 years and over by highest level of schooling)

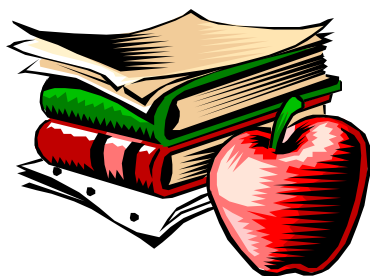
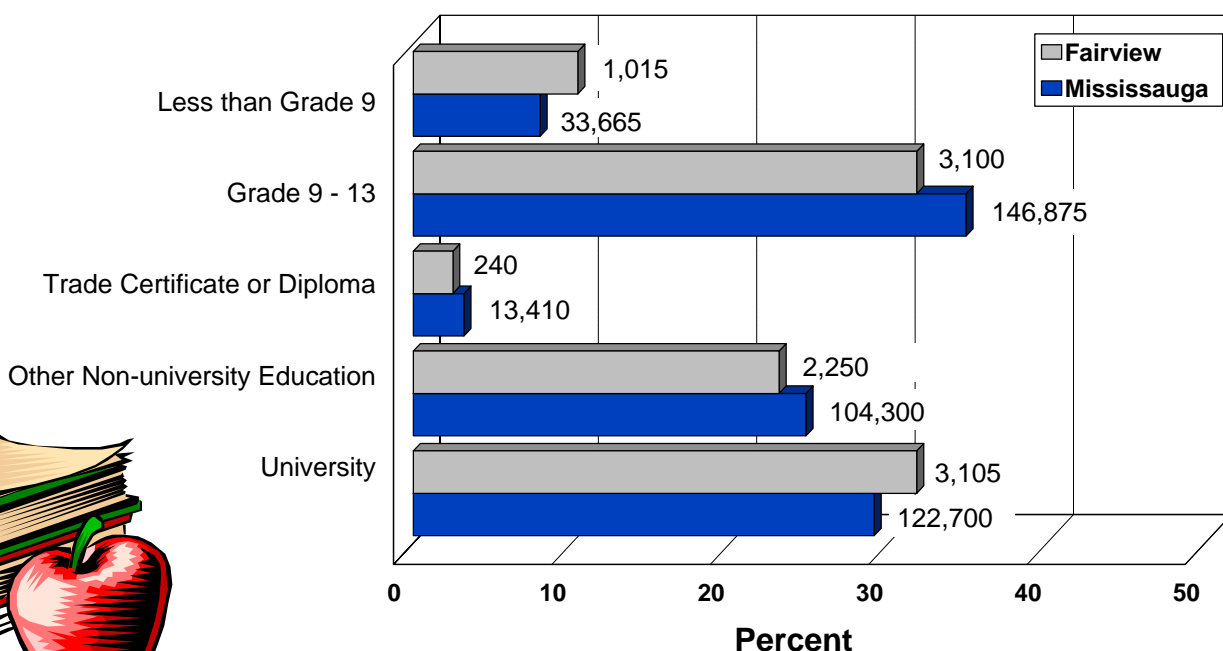

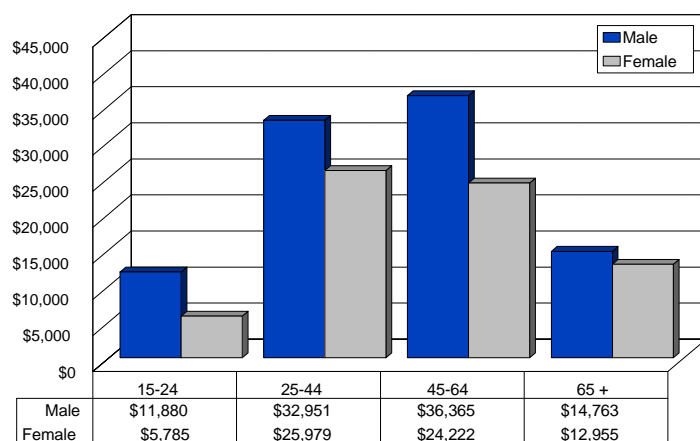

**Average Total Income**

Refers to the average total money received from the following sources during calendar year 1995 by persons 15 years of age and over: wages and salaries; net farm income; net non-farm income from unincorporated business and/or professional practice; federal Child Tax benefits; Old Age Security pension and Guaranteed Income Supplement; benefits from Canada or Quebec Pension Plan; benefits from Unemployment Insurance; other income from government sources; dividends, interest on bonds, deposits and savings certificates, and other investment income; retirement pensions; superannuation and annuities, including those from RRSPs and RRIFs; other money income.

Census Family

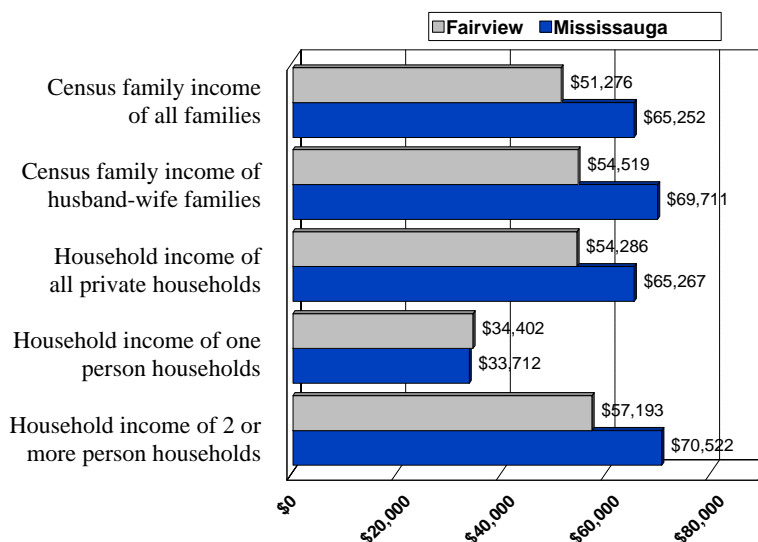
Refers to a now-married couple (with or without never-married sons and/or daughters of either or both spouses), a couple living common-law (with or without never married sons and/or daughters of either or both partners) or a lone parent of any marital status, with at least one never-married son or daughter living in the same dwelling.

Household

Refers to a person or a group of persons (other than foreign residents), who occupy the same dwelling and do not have a usual place of residence elsewhere in Canada. It may consist of a family group (census family) with or without other non-family persons, of two or more families sharing a dwelling, of a group of unrelated person, or of one person living alone.
